

Calling Applications for Recruitment to Grade III of the Post of Electrician (Primary Grade - Skilled Service Category) of the Department of Health Services, Central Province – Open

Applications are invited from qualified candidates to fill 03 vacancies in Grade III of the post of Electrician (Primary Grade - Skilled Service Category) of the Department of Health Services, Central Province. The closing date for applications is 2026.10.02

02. In accordance with the provisions of Section 7.2 of the Scheme of Recruitment and Promotion for posts in the Primary Skilled Service Category (PL-3-2006 A) of the Department of Health Services, Central Province, approved by the Hon. Governor of the Central Province on 30.09.2014, candidates who have fulfilled the following qualifications as of **27.01.2026** are eligible to apply.

03. This post is permanent and pensionable. The salary scale applicable to the post:

Rs.42780– 10 X 490 -10 X 540 -10 X 590– 12 X 630– 66540

(i) Educational Qualifications: Having passed at least six (06) subjects with a minimum of two (02) credit passes in not more than two sittings at the General Certificate of Education (Ordinary Level) Examination, or having obtained the NVQ-3 qualification.

(ii) Professional Qualifications: Candidates must possess a National Vocational Qualification (NVQ Level 4) or higher certificate of proficiency relevant to the post, issued by a technical/vocational training institute recognized by the Tertiary and Vocational Education Commission (TVEC).

(iii) Experience: Not applicable.

(iv) Physical Qualifications: Every candidate must be physically and mentally fit to serve in any part of the Central Province and to perform the duties of the post.

(v) Other Qualifications

i. Must be a citizen of Sri Lanka.

ii. Candidates must be of excellent moral character.

iii. All qualifications required for recruitment to the post must be fulfilled in every respect as of the closing date specified in the notice calling for applications / Gazette notification.

iv. Only male candidates are eligible to apply for this post.

(v) Age:

Minimum Limit: Not less than 18 years

Maximum Limit: 45 years (The maximum age limit does not apply to those holding a permanent post in the government service.)

(vi). Method of Recruitment: Recruitment will be made based on the results of a written examination and a practical trade test. Initially, a written examination will be held, and candidates who pass the written examination will be called for the practical trade test in order of merit based on the marks obtained, up to twice the number of expected vacancies. Candidates who pass the practical trade test will be recruited according to the merit order of the total aggregate marks obtained in both the written examination and the practical test.

Installation and repair of electrical equipment, fault identification/troubleshooting in electrical units and machinery, electrical wiring, distribution, circuit design/planning, and maintenance/repair of electrical systems in buildings.	30 minutes	100	40%
